

**LEE'S FAMOUS RECIPE CHICKEN
"FAMOUS FAN" CONTEST
OFFICIAL RULES**

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES
OR THE DISTRICT OF COLUMBIA WHO ARE 18 YEARS OF AGE OR OLDER.

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE. Purchase Will Not Improve Chances Of Winning.

1. **ELIGIBILITY:** Open only to legal residents of the 50 United States or the District of Columbia ("U.S.") who are 18 years of age or older at time of entry. Entry via Twitter or Instagram: your account must be "Public"

Entries and other submitted material become the property of Sponsor and will not be acknowledged or returned. All Entries must be received during the Entry Period. Use of any automated system to enter as determined by Sponsor in its sole judgment is prohibited and will result in disqualification at Sponsor's sole discretion. Entries will be reviewed by Administrator for compliance with the entry parameters set forth, and if accepted, may be re-posted by Sponsor. - 4. JUDGING:** Entries will be judged by a panel of judges selected by Sponsor to select winner(s) throughout the contest period. Entries will be judged according to the following criteria: a) Creativity, b) Originality, c) Appeal, and d) How well the entry represents the "Famous Fan" theme. The judges' decisions are final and binding. Sponsor reserves the right in its sole discretion not to award a prize if no eligible entries of sufficient quality are received.

WINNER NOTIFICATION:** Winner(s) will be notified via the following methods: If winning photo was submitted via Facebook, winner will be contacted via Facebook comment and directed to the Lee's Famous Recipe Chicken Facebook page to send a private Facebook message. If winning photo was submitted via Twitter, winner will be contacted by @LeesFamousChick through Direct Message. If winning photo was submitted via Instagram, winner will be contacted through Instagram comment from Lee's Famous Recipe Chicken.
